Hiring the services of established business houses in garment manufacturing, marketing sector for establishing/running garment manufacturing unit in Bihar for establishing training centre, providing skill development training and providing job work to rural women on continuous basis in Bihar.

#### Introduction

Women Development Corporation, Bihar under the aegis of Department of Social Welfare, Govt. of Bihar has the vision to ensure overall survival, development, protection and participation of women and adolescent girls of the state. The objective is to formulate, promote and implement various schemes aimed at the development of women in Bihar. Key thrust of all programmes being implemented by WDC is primarily around economic and social empowerment through community based institutions and support groups.

## **Objective of Assignment**

In order to achieve these objectives, Women Development Corporation has envisioned contributing to economic development of women in the state through entrepreneurship promotion and enhancing employment opportunities for them in state of Bihar. The proposed project aims to utilize the potential of apparel sector for creating employment opportunities for unemployed women of Bihar by setting up training cum production unit. The centre will provide skill development training to women and also provide them opportunity of continuous working thereby increasing income opportunities for women in the state. WDC will establish the production cum training centre with all modern infra & machineries.

To fulfill the above envisaged tasks, it is proposed to collaborate with a business house in garment manufacturing sector / garment export and marketing sector to

- (i) Assist in establishment of garment manufacturing unit in Bihar
- (ii) Assist in establishment of training centre for garment manufacturing
- (iii) Provide skill development training
- (iv) Provide job work to skilled women on continuous basis
- (v) Manage all operations related to production and marketing

# Pre-Qualification Criteria (proofs to be attached)

- a) Organization registered under Company Registration Act or any other act of the land. A copy of the same should be submitted along with EoI
- b) Post Registration experience the organization should be in existence for atleast 5 years
- c) PAN No.
- d) Udyog Aadhaar
- e) GST
- f) Annual turnover must be Rs 5.00 cr. for last 3 financial years (Balance sheet to be attached)
- g) Not blacklisted by any government agency/ organization. A notarized affidavit is to be submitted in this regard

### Qualification Criteria

The agency is required to have at least 5 years post registration experience of the following: (proofs to be attached)

- The capacity and experience in establishing and managing garment manufacturing unit
- Providing skill training to women on garment manufacturing
- Experience in export business will be preferred. Import Export Certificate/license and Record of last 3 completed export orders should be submitted.

# Proposal Submission

Agencies should submit a proposal giving their Background, Turnover, Infrastructure and manufacturing facilities available, product in which they are dealing, Marketing Strategy etc.

# **Evaluation Criteria**

The proposal will be evaluated on the basis of background and experience of the Agencies. A presentation has to be given by the Agencies about their methodology and action plan. The agencies has to submit minimum three years action plan and indicate the number of women proposed to be trained and gainfully employed.



Since the centre will be established by the Women Development Corporation only Technical proposal will have to be submitted.

Firm having the best credentials and proposal will be shortlisted for allotment of the Work

#### Period of Assignment

The proposed assignment is initially for three years, extendable for further 3 years.

Women Development Corporation will sign a Memorandum of Understanding with the shortlisted agencies.

#### How to apply

The pre qualification envelop shall be evaluated initially and EoIs of only those agencies which fulfill this criteria would be taken up for appraisal.
